4.1 Description of first aid measures

7.1 Precautions for safe handling

Protective measures	: Put on appropriate personal protective equipment (see Section 8). 8.2 Exposure controls

Appropriate engineering controls : Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. Skin protection
