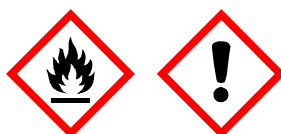

## Section 4. First aid measures

### Description of necessary first aid measures

### Precautions for safe handling

- Protective measures
