### Section 2. Hazard identification

This product contains TiO2 which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification. #### Section 4. First-aid measures

#### **Precautions for safe handling**

#### **Protective measures**

**Recommended monitoring**: Reference should be made to appropriate monitoring standards. Reference to national guidance documents for methods for the determination of hazardous substances will also be required.

**Appropriate engineering** controls

: Use only with adequate ventilation.
