#### 4.1 Description of first aid measures

# **SECTION 5: Firefighting measures**

Hazards from the substance or mixture : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. ### 7.1 Precautions for safe handling

#### **Protective measures**
