Precautions for safe handling

Section 8. Exposure controls/personal protection

Formaldehyde is a known cancer hazard, a skin sensitizer and a respiratory sensitizer. If splashed in the eyes, the liquid may cause irritation and reversible damage. Ingestion may cause nausea, diarrhea and vomiting.
