Special provisions

One possible (flammable) decontaminant comprises (by volume): water (45 parts), ethanol or isopropyl alcohol (50 parts) and concentrated (d: 0.880) ammonia solution (5 parts). A non-flammable alternative is sodium carbonate (5 parts) and water (95 parts). Section 7. Handling and storage

Precautions for safe handling

Other information

Prolonged or repeated contact may dry skin and cause irritation.
