Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. #### 7.1 Precautions for safe handling

**Protective measures**

#### 8.2 Exposure controls
