# **SECTION 5: Firefighting measures**

#### 5.1 Extinguishing media

Suitable extinguishing media

: Use dry chemical, CO2, water spray (fog) or foam.

#### 5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture

: Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. Recommended monitoring procedures
