Conclusion/Summary	:	Fhere are no data available on the mixture itself. This product either contains formaldehyde or is capable of releasing formaldehyde above 0.5 ppm under certa conditions. Formaldehyde is a known cancer hazard, a skin sensitizer and a respiratory sensitizer. This product contains crystalline silica which can cause lur cancer or silicosis. The risk of cancer depends on the duration and level of exposite dust from sanding surfaces or mist from spray applications. For many product TiO2 is utilized as a raw material in a liquid coating formulation. In this case, the TiO2 particles are bound in a matrix with no meaningful potential for human exposure to unbound particles of TiO2 when the product is applied with a brush or roller. Sanding the coating surface or mist from spray applications may be harmf depending on the duration and level of exposure and require the use of appropriat personal protective equipment and/or engineering controls (see Section 8).
