#### **6.2 Environmental** precautions

: Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilt product.

#### 8.2 Exposure controls

Appropriate engineering controls
