#### 5.3 Advice for firefighters

**Special precautions for fire-fighters** 

: Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. ### 7.1 Precautions for safe handling

### **Protective measures**
