### Section 2. Hazards identification

This product contains TiO2 which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification. # Section 5. Fire-fighting measures

Specific hazards arising from the chemical

#### Precautions for safe handling

**Protective measures**
