# Section 5. Firefighting measures

Specific hazards arising from the chemical

# Section 7. Handling and storage

#### Precautions for safe handling

**Protective measures** 

Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. #### Other information
