Section 4. First aid measures

Precautions for safe handling

- Protective measures

Do not ingest. Avoid the creation of dust when handling and avoid all possible sources of ignition (spark or flame). Prevent dust accumulation. Use only with adequate ventilation. Appropriate engineering controls : Use only with adequate ventilation.
