GENERAL DESCRIPTION

FLOOD Pro Series Wood Cleaner is a unique, premium quality product for restoring the clean, refreshed look to exterior wood and other surfaces. It cleans stains caused by mildew, dirt, algae and mold without scrubbing. Unlike bleach alone, **FLOOD Pro Series Wood Cleaner** works on the surface to lift dirt that can then be rinsed away. This product contains no phosphates, acids, solvents or petroleum distillates. When used as directed, it will not harm most plants, pets or fish.

RECOMMENDED USES

Use on decks, wood siding, shakes, shingles, and fences. Also recommended for use on concrete, brick, stucco, tile, and vinyl. Use of this product may return the original green color to pressure treated wood. Application of this product may cause a fuzzy appearance to wood previously damaged by pressure washing or excessive weathering. Application to new wood or newly sealed wood may cause spotting and discoloration. May cause redwood to darken. Test in a small inconspicuous area and let dry before application.

PRODUCT TYPE: Sodium Hypochlorite Solution

WEIGHT/GALLON: 8.9 lbs. (4.1 kg) +/- 0.2 lbs. (91 g)

COVERAGE: One gallon (3.78 liters) will clean approximately 250-300 sq. ft. (23.2-27.9 sq. meters). Coverage will vary depending on type, age and texture of wood.

RECOMMENDED SPRAY EQUIPMENT: Use a plastic, pump-style garden sprayer and hose.

CLEANUP: Rinse tools and spray equipment thoroughly with water.

STORAGE: Store in a cool dry location in tightly closed plastic container. Avoid exposure to sunlight. Do not reuse container. Rinse container thoroughly before disposal.

DISPOSAL: Contact your local environmental regulatory agency for guidance on disposal of unused product. Do not pour down a drain or storm sewer.

DIRECTIONS FOR INTERIOR AND EXTERIOR USE

AREA PREPARATION: Spray all plants and vegetation liberally with water before and after application. Cover delicate vegetation to avoid damage. Do not allow to come in contact with metal, fabric, floor coverings, or lawn furniture.

SAFETY PRECAUTIONS: Wear chemical resistant gloves, safety goggles and protective clothing. Do not mix with any other chemicals or other household cleaning products as hazardous fumes may result. Surfaces are slippery when wet. Use caution when walking on wet surfaces during application.

APPLICATION: Surfaces to be cleaned must be thoroughly dry. **FLOOD Pro Series Wood Cleaner** should be applied at full strength with spray equipment recommended below. When treating vertical surfaces, apply from bottom to top. Spray the affected area liberally and allow to stand for 5-10 minutes. **NO SCRUBBING NECESSARY.** Cleaning action will occur within minutes. Thoroughly rinse treated surface and surrounding areas with large amounts of water to neutralize cleansing action. A second application may be applied if necessary.

FOR PERIODIC CLEANING OF COMPOSITE DECKING: Apply **FLOOD Pro Series Wood Cleaner** liberally and work into surface with a stiff broom (slight foaming should be seen, it not apply more cleaner). Rinse, let dry, apply a second application if needed. Slight yellowing of the deck is normal and will fade in a matter of days.
